

INFORMATIVE NOTE FOR SUPPLIER ABOUT COLLECTION OF PERSONAL DATA PURSUANT TO ART.13 OF THE REGULATION UE 2016/679

Nature of the treatment

Purpose of the treatment

Pursuant to article 30 Reg. UE 2016/ 679 in these cases the consent is not compulsory and hence, in the event of non-acceptance of treatment of data you will have to give expressed and written cancellation.

Your data may be communicated, for the purposes indicated, to:

- whoever is reading is consignee of communications provided for by law or regulations;
- consultants of our company;
- assigned to the management of administrative services, to the provision of services, agents or representatives.

We will not spread your data to indeterminate or not authorizes subjects.

Rights of the person concerned

From the processing in question, to the person concerned, it is recognized the exercise of data access rights, correction and cancellation, (right to the oblivion), limitation of processing, portability, opposition to the processing (art. 15, 16, 17, 18, 20, 21 reg. UE 2016/ 679) and the right to make a complaint to a supervisory authority.
